

Promotion Participation Terms and Conditions

Trading accounts that utilise expert advisors/programming, utilise 400:1 leverage, or those that are funded via credit card are not eligible for this promotion.

The client must meet the requirements specified by NOVOX in Table 1: Promotion Criteria by making, at minimum, the required initial margin deposit, completing the trading requirements within the stated time limit and following the withdrawal rules.

NOVOX will start recording the traded lots associated with this promotion on the day the client funds his/her account. The client acknowledges that in the event he/she makes a withdrawal of margin related to this promotion before receiving his promotional item, the client forfeits his/her promotion eligibility and forfeits receipt of the promotional item.

NOVOX will not make any guarantee for the receipt time of the promotion item. Receipt time is based on the product's availability in the retail market.

The promotional item will be shipped or transferred to the client within 10 business days after NOVOX verifies that the client has fulfilled his/her promotion requirements, NOVOX will not be responsible for any loss, damage or non-receipt of the promotional item once it is transferred or shipped to the client.

Before the trading requirements are fulfilled if client withdrawal any part of any of the initial margin deposits (trading profits excluded), or account equity is less than the value of gift item, an amount equal to the gift item value will be deducted from clients trading account.

Any position holding less than 1 minute are NOT calculated as promotion trading requirements.

In the event that NOVOX has reason to suspect that a client has abused or attempted to abuse the promotion, has used specific programs to cheat or has otherwise acted with a lack of good faith, NOVOX, at its sole discretion, reserves the right to deny, withhold or withdraw from the client his/her eligibility to participate in the promotion. NOVOX is entitled to automatically deduct an amount equal to the stated value of the earned promotional item from the clients NOVOX trading account.
